# Nebraska CASA Facts

- 788 Nebraskans volunteered as advocates in 2024.
- 1,936 Nebraska children had a CASA volunteer in 2024.
- Volunteers donated 31,019 hours of their time and traveled 235,202 miles in 2024.
- 6,098 child visits were conducted by volunteers in 2024.
- 1,300 Nebraska children are without a volunteer advocate.
- 22 local CASA programs serve 55 counties in the State.
- CASA programs have served Nebraska children for 38 years.

#### CASA stands for Court Appointed Special Advocate

Court Appointed Special Advocates are volunteers who are appointed by judges to speak in court for the safety and well-being of an abused or neglected child.

#### Who we are

CASA volunteers come from all walks of life. More than half of CASA volunteers are employed full time. CASA volunteers are well-trained and supported by competent and professional staff.

### What we do

CASA volunteers spend time with children and those involved in their case. They provide reports to the judge on the best interest of the child.

#### Why we do it

Children with a CASA volunteer receive more services, spend less time in foster care, have better outcomes in school. They know there is one caring adult dedicated to them simply because they care.

# **Our Impact**

### Support

Judges, attorneys, child protective workers and parents overwhelming report that CASA volunteers make a difference in the lives of the children they serve.

### Assistance

Children with a CASA volunteer are half as likely to spend time in long-term foster care, defined as more than three years in care. Also, cases involving a CASA volunteer are more likely to stay permanently closed.

### Influence

Fewer than 10% of children with a CASA volunteer re-enter the foster care system.



### CASA Best Interest Advocacy

CASA Volunteers advocate for the best interests of children who have experienced abuse or neglect

#### Learn and Engage

CASA volunteers learn all they can about the child and his or her family life. They then engage with the child during regular visits.

#### Recommend

CASA volunteers speak up for the child's best interests in court. They make recommendations regarding the child's placement and needed services.

### BEST INTEREST ADVOCACY

#### Collaborate

CASA volunteers collaborate with others to ensure that necessary services are provided and are in the child's best interest.

#### Report

CASA Volunteers report what they have observed and learned in court. At the same time, they monitor the child's situation until their case is released by the court.

## NEBRASKA GASA FINANGIAL IMPACT

#### **Return on Investment**

For **every \$1 invested** in Nebraska CASA, **\$6 are returned** to the state of Nebraska. The average cost of a CASA volunteer is \$3,018, and total benefits they provide are \$18,122.

#### Investment Impact - Taxpayers

Per child, Nebraska CASA indirectly saves taxpayers **\$13,898** in reduced administrative costs and reduced costs to the public.

#### Investment Impact - Beneficiaries

Per child, Nebraska CASA assists direct beneficiaries by **\$4,224** by assisting children with improved health and increased safety, along with impacts on the child's future earnings.
